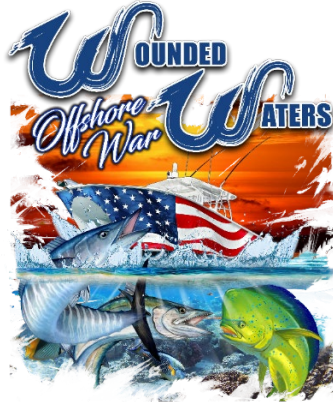

1) PAYMENT FOR SPACE

- a) Full Payment to procure guaranteed space required
- b) Vendor Space 10x10 \$100 (Includes Both Days / 24-25 May 2024)
- c) Approved Veteran and Non-Profit Organization Price \$75
- d) All forms of payment (Cash, Check, Credit/Debit Card and Venmo will be accepted. Any Credit Card or Processing Fees incurred will be added during payment.
- e) Space Agreement and Payment, if not executed in person with a Wounded Waters representative is to be mailed to:

2) CANCELLATIONS AND SPACE CHANGES

- a) If an exhibitor wishes to cancel this agreement, he must contact a Wounded Waters representative within 30 days of the show start and the cancellation must be confirmed in writing.
- b) Space changes are subject to approval by an Event Representative.

3) SUBLEASING

- a) Exhibitors may not sublease any portion of their purchased space without prior authorization in writing.

4) LIABILITY, RELEASE, WAIVER AND INDEMNIFICATION

- a) Exhibitor releases Wounded Waters Inc., their officers, directors, employees, agents, and volunteers from any claim, liability, losses, costs or expenses relating to or arising out of any injury to any personnel of exhibitor, or to any other persons or any damage to any property of exhibitor. The Exhibitor shall be responsible for such injury, loss or damage and any expenses relating thereto.
- b) Exhibitor shall indemnify, hold harmless, defend and reimburse Wounded Waters Inc., their managers, contractors, directors, officers, employees, agents and volunteers from any and all actions, claims, demands, liabilities, losses, attorney fees, cost of litigation which indemnities for any reason resulting from, relating to or arising out of Exhibitors participation in the Fishing Tournament; including but not limited to the negligence, gross negligence, criminal acts and any injury to or death of any persons or any loss through theft or otherwise damage to property.
- c) This agreement shall be governed by and construed in accordance with the substantive law of the State of Florida.

5) INSURANCE

- a) Exhibitor is required to provide and keep in force during the show period, including move in and move out periods the following insurance:
- b) General Liability (or its equivalent) including products, completed operations, personal and advanced liability with a per occurrence limit of not less than \$1,000,000.

6) GENERAL INFO

- a) All vendors are required to have a portable fire extinguisher at their booth and follow all local/federal laws.
- b) All vendors will be required to maintain a clean area (Dumpsters will be on premises for Vendor use)
- c) Vendor Space is 10'x10' per entry
- d) Veteran and Non-Profit Organizations receive special pricing (Consult your Wounded Waters Representative)
- e) 24 May Setup 2-4pm, Captains Meeting & Party Starts 6pm / 25 May Setup 7-9am, Event Closes after Awards Presentation.
